# **Annual report 2020**

1. Scientific activity: In 2020, the Swiss Sociological Society (SGS, https://www.sgs-sss.ch/) had three issues of the Swiss Journal of Sociology published with 24 articles. (See for open access https://content.sciendo. com/view/journals/sjs/sjs-overview.xml). In 2020, two bulletins were furthermore published, which are also accessible open access as pdf (see homepage). One of the bulletins includes the reports of the president as well as those of the research committees (RCs). In view of the far-reaching social impact as well as the repercussions on teaching and research, the SGS has also initiated a thematic bulletin with the thematic focus "The Covid-19 pandemic, health and medicine: Sociological investigations and perspectives" (https:// www.sgs-sss.ch/wp-content/uploads/2021/01/SGS-Bulletin-157.pdf). Editors are Michael Gemperle (Zurich) and Raphaël Hammer (Lausanne). The bulletin includes analyses of the change and social construction of the concept of health, the capacity of institutions and professions to respond to the pandemic, and the impact of the COVID-19 pandemic on increasing (pre-existing) social inequalities. Due to the COVID-19 pandemic, some planned events have been postponed, such as the Methods Festival (now scheduled to take place in St. Gallen in 2022). Other events of the research committees (RCs) could be held, some of them digitally. These include the one-day conference "Sociology of Health and Medicine in Switzerland: Trends and Challenges" (RC Health and Medical Sociology), the online conference "Discrimination and racism in the labor market" (RC Migration and Minorities) or the conference on "Sustainability through Arts" (RC Sociology of Art and Culture). In 2020, the first volume of the publication series «Panorama Gesellschaft Schweiz 2020» with the title "Migration - Integration - Participation" was published. This series was initiated by Christian Suter, it is located at the Federal Statistical Office (Neuchâtel) and is financially supported by the SAGW (Download link: https://www.bfs.admin.ch/bfsstatic/dam/assets/13927579/master).

2. Cooperation and international relations: SGS continues to be an active member of the European Sociological Association (ESA, https://www.europeansociology.org/) and the International Sociological Association (ISA, https://www.isa-sociology.org/en). Where possible, members of the SGS Board also attend the relevant committee meetings of ESA and ISA. Many members of the SGS are part of sections of ESA and ISA. Finally, a joint work-shop on "Public Sociology" (organized with the German Sociological Association DGS and the Austrian Sociological Association ÖGS) was held in October 2020 at Essen.

3. Public relations: The board member Marlyne Sahakian (University of Geneva) has continued to update the information for the sociology BA and MA programs in Switzerland (on the SGS homepage) and completed it by the end of 2020 (https://www.sgs-sss.ch/de/studium/). The SGS homepage (https://www.sgs-sss.ch/de/) is still important for information about news, conferences as well as activities of the research committees. In addition, there is a newsletter that can be subscribed to. It is sent to all members of the SGS. Several issues were sent to the subscribers in 2020. The newsletter is available for download on the homepage at https://www.sgs-sss.ch/de/die-gesellschaft/newsletter/.

4. Administration: The administration of the SGS is done first of all by the cooperation between president, vice-president and treasurer. Until the end of 2020 Christian Suter (University of Neuchâtel) acted as Vice President. Since 2020, Oliver Nachtwey (University of Basel) serves as treasurer. In 2020, the General Assembly could only take place digitally — due to the COVID-19 pandemic. Felix Bühlmann (University of Lausanne), Muriel Surdez (University of Fribourg) and Christian Suter (University

of Neuchâtel) left the board. Patrik Aspers (University of St. Gallen), Achim Edelmann (University of Bern) and Regula Julia Leemann (FHNW Basel-Muttenz) were newly elected to the board. In addition, Christoph Mäder (PH Zurich) and Claudine Burton-Jeangros (University of Geneva) were elected as revisors. (See also the minutes of the general assembly.)

5. Information on planned activities, initiatives, projects. In 2020, the SGS and the organizing team in Geneva (Milena Chimienti and Marlyne Sahakian) have moved forward with the organization of the Sociology Congress in Geneva. It will take place with the congress title "Social Justice in Times of Crisis" from June 28 to June 30, 2021. Several events will be organized

by members of the SGS as part of the SAGW series of events "(Ir)Responsible Consumption". These are the events "Sustainable consumption and well-being" (Jörg Rössel, University of Zurich/Marlyne Sahakian, University of Geneva), « Consommation, suffisance et bien être » (Marlyne Sahakian and Orlane Moynat, both University of Geneva) and « Big Bounce: Consommer dans une économie verte » (Philip Balsiger, University of Neuchâtel). In addition, the individual research committees are planning further conferences and workshops in 2021 and a sociological comic book will be produced (by Daniel Burnier and Thomas Jammet, University of Neuchâtel).

## 3. Report

#### a) President

The SSA board initiated a bulletin on the issue of health, in relation to the COVID-19 pandemic. This will be coordinated by Michael Gemperle and Raphaël Hammer and will be published in the beginning of 2021. Marlyne Sahakian took care of updating the information on study programs in sociology in Switzerland on the homepage of the Swiss sociological association; the task has been completed and we can be reimbursed by the ASSH this year.

#### b) Events

Together with the German Sociological Association and the Austrian Sociological Association, SSA initiated a workshop "Public Sociology", which took place 1–2 October 2020 at Kulturwissenschaftliches Institut at Essen. Some other of the planned conferences of

the research committees in 2020 had to be postponed because of the COVID-19 pandemic.

## 4. Accounting 2019 and budget 2021

### Accounting 2019

In 2019 the membership fees declined. The SSA secretary had to remind several members to pay their fees. It was discussed that the pandemic could be troubling for some members, which could be the cause for delayed payments. In the general assembly, the SSA board was reminded to approach the task to reduce costs and asked to carefully examine the financial situation of the association, to ensure its long term health and viability. The president explained that this will be discussed and approached in relation to the journal reform, which is expected to cut the expenses of the SSA substantially. But it was also agreed on to gain more members for SSA, which will be a future task of the SSA board, too. Still, the budget situation is not transparent in every aspect. One reason is that SAHS funding is to be applied for one year before and accounting is done one year after.

#### **Budget planning 2021**

The planned budget was presented and discussed. It was accepted by the general assembly.

## 7. Report of the Swiss Journal of Sociology

The journal editor Felix Bühlmann reported that less articles are coming in, the editors have to invest to get more submissions. There are several special issues forthcoming: Migration, Non take up of social policies. More focus issues are planned. The journal editor announced to step down at the end of 2020. The journal is going to have a group of editors in the future, four people: Sophie Mützel (Luzern), Judith Nyfeler (St. Gallen), Luca Pattaroni (EPF Lausanne), and Marc Perrenoud (Lausanne). A new advisory board is planned, too. The international board will continue.

#### Activities 2020

In spite of the pandemic and the difficulties resulting from the sanitary situation, the RC-SAC — or Foko-KUKUSO for its intimates — held several activities in 2020. Even during such an unstable year all around the world, the research committee has continued to be prolific in its 11<sup>th</sup> year of existence, having been founded in 2009:

1. Book publication on arts and markets. First of all, the edited book The Sociology of Arts and Markets. New Developments and Persistent Patterns is now published by Palgrave-Macmillan, in their "Sociology of the Arts" series. The book is an outcome of the international conference "Arts and Markets" organized by the RC-SAC with colleagues at the University of St. Gallen at the end of 2016. The book's editors Andrea Glauser, Patricia Holder, Thomas Mazzurana, Olivier Moeschler, Valerie Rolle, and Franz Schultheis assembled 17 contributions from both young and more senior scholars from Japan, Switzerland, France, Italy, China, the US, and UK. In their respective contributions, the authors

- analyse the complex relationships between the arts and their markets along the following axes:
- Creators in the Market: Artists between Aesthetics,
   Critique and Trade
- Artistic Career Paths. Trajectories and Inequalities in the Market
- The Economy of Idiosyncrasy: Art dealers and the Commodification of Individuality
- Marketable Art: Galleries and Gallery Owners as Central Intermediaries
- Market Assessments: The Increasing Role of Art Rankings
- > Features of the Art Market in Advanced Capitalism: From Established to New Patterns?

2. International conference on arts and sustainability. In February last year, the RC-SAC launched a call for papers for an international conference on "Sustainability through Arts" scheduled to take place in Geneva in September 2020, the conference was financed by seed funding granted by the SAGW-ASSH aiming to promote scientific contributions to the UN 2030 Agenda and the Sustainable Development Goals (SDGs). The scientific and organising committee was composed of Marylene Sahakian, Nuné Nikoghosyan and Loïc Riom (University of Geneva), Guy Schwegler (University of Lucerne) and Olivier Moeschler (University of Lausanne). The main purpose of the event was to render visible what is being done in the relatively recent field of "arts and sustainability", engage in debates and discussions between different actors working in the field, and explore future research and research-action directions. The conference was structured around two main questions:

- > What is the environmental and social impact of art?
- How can art support transformations towards more sustainable societies?

Despite the pandemic, which began to unfold shortly after the call was launched, preparations for the event continued. The conference finally took place as planned on 24–25 September 2020, but in a semi-virtual format: Swiss scholars met at the cultural premises Les Saules in Geneva, while all other participants joined online via videoconference. The event brought together some 50 participants, both researchers and practitioners, from around the world to discuss issues related to art and sustainability in all its forms. Over 30 scholars from France, Germany, Italy, the Netherlands, UK, Japan, and Switzerland gave 14 presentations. These presentations were supplemented by a world café and two keynote presentations by Karin M. Ekström (University of Borås) and by Nicolas Nova (HEAD Genève) and François Ribac (University of Burgundy-Franche-Comté). The abstracts of all presentations, an introduction with reflections on the conference as well as links to further material can be found in the proceedings published online through SCORAI (Sustainable Consumption Research and Action Initiative. https://scorai.net/international-conferences/). After the conference, a research network was created to continue exchanges on this current topic: the Sustainability to Art Network (STAN). This new network currently revolves around a mailing list (subscribe here) and a Twitter account (@sustain\_art).

 Panel on music at STS conference. Lastly, the Foko-KUKUSO was also associated in the organisation of a panel on music, infrastructure, and fragility at the conference "Multiple Matters: From neglected things to arts of noticing fragility". The Swiss STS association organized the conference at University of Lausanne (7–9 September 2020 – postponed to 15–17 February 2021) and Loïc Riom from our scientific committee was involved in setting up the panel. It included Swiss and French researchers working in the field of sociology of arts.

#### Planned activities 2021

This year, the RC-SAC is planning the following activities:

- A workshop (*journée d'études*) at the University of Nantes on "Artistic Creation" with a grant from the SAGW-ASSH (planned for January 2021, postponed to 18 June 2021).
- paper sessions as well as a semi-plenary session on "Arts and Culture in Times of Crisis" at the SSA Congress at the University of Geneva (28–30 June 2021).
- a possible participation to a session at the Dreiländerkongress organized by the DGS-ÖGS on «Die Post-Corona-Gesellschaft? Pandemie, Krise und ihre Folgen» in Vienna (23–25 August 2021).

#### Activities in 2020

Despite the Covid-19 pandemic, our research committee (RC-SHM) organised a one-day conference "Sociology of Health and Medicine in Switzerland: Trends and Challenges", which was hosted at the School for health professions in Lausanne (HESAV - HES-SO) on 2 October 2020. The objective of this event was to celebrate 40 years of activities of our research committee "Sociology of Health and Medicine", by addressing some significant developments of the field over the last years, its current situation and future challenges. The conference included different kinds of contributions as the programme included three keynote speakers (Karen Lowton, University of Sussex; Patrick Brown, University of Amsterdam; Peter Meyer, former director of the ZHAW health department, with Thomas Abel as discussant, University of Bern), a session dedicated to young researchers' presentations (Luna de Araujo, Mike Deml, Vladimir Jolidon, Audrey Linder and Andrea Lutz), two topical workshops and an E-poster session. Between two waves of the pandemic, the conference was successful with more than forty participants in Lausanne, who enjoyed the scientific and informal

exchanges. We thank the following institutions for their financial support: Haute Ecole de Santé Vaud (HESAV), the University of Applied Sciences and Arts Western Switzerland (HES-SO), the Swiss Academy of Humanities and Social Science (ASSH/SAGW), the Population Health Laboratory of the University of Fribourg, and the RC-SHM. The research committee has organized a workshop for young researchers at the HETSHES-SO Fribourg in September 2020 to promote exchanges and networking. The aim of the workshop was to bring together young researchers from the German and French-speaking parts of Switzerland who deal with social problems, social policy, social insurance, institutions, discourses (etc.). Five young researchers from both French and German-speaking Switzerland conducting research at both university and university of applied sciences level participated to this meeting. In total, there were twenty participants. The meeting was very successful regarding the main objective, which was to exchange ideas and network. After this first meeting, the research committee plans to organize a networking meeting once a year.

#### Planned Activities 2021

In the context of the congress of the Swiss Sociological Association on "Social Justice In Time of Uncertainty", which will take place in Geneva from 28 to 30 June 2021, the research committee "Social problems" will

organize one panel "Who deserves what? Social policy and deservingness in times of crisis". The aim of the panel is to discuss the notion of deservingness in the light of the crisis of COVID-19.

This does not correspond with our view of a diversified research community. We therefore would like to call for sociologists working in Universities in Switzerland to become active in the network.
